





PROTECTION POLICY

We are the Board of WFDYS and Organizing Committee of the WFDYS Children's Camp, our goal is to ensure the safety of all children and staff at the WFDYS Children's Camp during October 1st - 7th, 2022 in Colonia, Uruguay.

Prohibition:

- Alcohol consumption
- Consumption or storage of drugs
- Sexual abuse and / or aggravation
- Violence

In any case, acting on the various situations to be considered as minor, semi-serious or serious offenses, immediately requires a meeting with the WFDYS Board and the WFDYS Children's Camp Organizing Committee, to make sanctioning measures. It could be returned from your country and we notify the police.
